1. Shadowing experience for outstate Minnesota SANEs

- A. MN IAFN Chapter working in collaboration with MNCASA to provide experiences for nurses currently employed in Healthcare, already taken the 40 hour SANE training,, and will work as a SANE in outstate Minnesota.
- B. 5 signed up so far, one from International Falls.
- C. MNCASA has a grant that will provide lodging and mileage for those participating, the Grant ends in April 2011.
- D. The MN Chapter will continue to provide the shadowing experience, without the reimbursement in the future.

2. SANE Training will be April 18-22, 2011

- A. MNCASA has a grant to sponsor a 40 hour SANE training in collaboration with the MN IAFN Chapter. The focus of the grant is to train outstate Minnesota nurses.
- B. The MNCASA grant will pay Linda Ledray's fee, some meals, materials, and reimburse tuition for up to 30 outstate Minnesota Nurses.
- C. The MN IAFN Chapter will organize, register, collect payment and distribute reimbursements.
- D. The training will have 10 open slots for out of state nurses as well as metro area nurses. The cost will be \$150 in state and \$325 out of state.
- E. Payment for those eligible will be collected prior to the training and reimbursed on completion of the 40 hours.
- F. Wednesday, April 20th we will have a "Social Hour" at the Roasted Pear (or some other restaurant) for the MN IAFN Chapter to meet the attendees.

3. The idea of starting a library or a catalogue of resources available from all the metro area programs was discussed.

4. Education ideas for 2011 were discussed.

- A. SANE A review course was planned for April 9th, location to be determined.
- B. Sharon, Ellen, Barb, Gail, Kathryn and Karine will plan this event.
