During the evening of Dec. 10<sup>th</sup> from 7-9 pm, the Center for Victims of Torture will present a documentary called "Beneath the Blindfold" at the Bell Museum Theater, located on the University of MN campus, Minneapolis (10 Church St. SE). This film describes some tortured

individual's experiences and steps that they have taken towards healing. There will be a post film discussion.

On Wednesday, Dec. 12 from 11a-12:30pm Central Time there is an IAFN webinar titled *Straddle Injury vs. Sexual Abuse - Managing Traumatic Genital Injury in Children*. It is helpful for healthcare providers when caring for children who are suspected of being sexually abused.
