- ❧ Cass Lake – 7: 6 female, 0 male, 0 suspects
- ❧ Grand Rapids – 115: 5 female, 0 male, 0 peds, 0 suspects
- ❧ Hennepin County – 644: 572 female, 47 male, 75 peds, 25 suspects
- ❧ Mankato - 38 cases: 37 were female, 1 male, 1 suspect
- ❧ Regions – 187 – 180 female, 7 male, 0 suspects
- ❧ St Francis – 30: 28 females, 0 male, 1 suspect
