1. Barb reported that a nurse from Japan would like to visit the Twin Cities SANE programs at the end of August. Ellen and Linda volunteered to give tours.
2. Should we have a SANE A review class in September?  
Ellen has 2 nurses taking the exam, Linda will check with Chip and Cassandra to see if they have nurses scheduled to take the exam too before we decide.
3. New logo for the our chapter was made by Jess Cheney (Linda's daughter) see attachment Kathryn will check to see what the cost for having it digitized would be and then it could be sewn on to polar fleece jackets for a fund-raiser. The logo will also be used on cards and official chapter documents in the future. The IAFN home office approved the logo on 8/11/11
4. September 13, 2011 Education: Megan Alama and Der Her will speak, it will be at the Allina Commons Owatanna room. So far, 27 people have sent in RSVP. Advocates were invited and more than half of the RSVPs are advocates.
5. IAFN Officer Training webinars, we missed them. Are they archived? Linda is checking with the IAFN. (See Bonnie Barsa's email below for more details)
6. October 1, 2011 conference: We looked at the agenda, schedule, budget and supply list.

Budget of ~ \$2,00 was approved with the addition of paying for rooms for presenters and mileage from the Twin Cities and having only one conference room. Budget based on 50 people attending at \$40 each= \$2000. Schedule was changed to put documentation session last. The conference was submitted to the IAFN to post on the education page. Flyers sent to 60 hospital trauma coordinators, Sara Gonsalves sent flyer out to all the SMART teams and Leah has sent it to all of her contacts. Linda will start asking all the presenters for bios and objectives to prepare the CEUs and certificates of attendance. Linda will also ask for the power points to start printing for the attendees. Kathryn, Barb and Linda will go to Grand Rapids on Friday to help set up the conference.

7. Next education will be on November 15, 2011, tentative topic will be: Trafficking/sexual exploitation. Ellen will ask Vedinta Carter or Joy Friedman of Breaking Free to present and someone from Civil Society to present. <http://civilsocietyhelps.org> Location to be determined, possibly at Regions. We will also invite advocates to attend.
8. Prison Rape Elimination Act and possible speakers was discussed for our March 2012 education.
9. Treasurer report: We have ~ \$5000 in the bank.
